Categories of the data processed

Navigation data

Computer systems and the software procedures used to operate this website acquire, throughout their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. Such information is not collected to be associated with identified data subjects, but it allow data subjects to be identified thanks to its very nature. This category of data includes IP addresses or domain names of the computers used by users who connect to the site, URI (Uniform Resource Identifier) addresses of the requested resources, time of the request, method used to submit the request to the server, size of the file obtained in response, numerical code indicating the status of the response given by the server (successful, error, etc.) and any other parameters relating to the operating system and to the user's IT environment. Such data are used only to obtain anonymous statistical information on the use of the site and to check its correct operation.

Data could also be used in order to ascertain responsibility in the event of hypothetical computer crimes against the site.
